

Secretariat Papers

The Secretariat Papers comprise documents from the office of the colonial governor's secretary, which was located in the same building where the Uganda National Archives have been housed since their inception. The Secretariat Papers consist primarily of correspondence that passed through the governor's office, but also contain reports and official publications. The content of these files is broad, covering all aspects of administration handled by the Governor and Chief Secretary. Thus, this collection contains material on topics ranging from education to agriculture, and from taxation to foreign relations, with much more in between. The earliest materials are correspondence and circulars dating back to the 1880s. Files of correspondence pick up in the 1900s and continue until independence in 1962, though the bulk of the collection dates from before World War II.

Over the years, administrators and archivists have classified this material under several distinct cataloging systems. Many of the documents were originally marked with a Minute Number or other such identifying mark by their original creator. Others were reclassified later under different classificatory systems. In the early 1950s, Patrick English, the government archivist at the time, organized the papers up to 1929 under regional deposits, and some of the papers after 1929 under topical headings corresponding with letters in the reference number. However, his tenure ended before completing this effort. Subsequent archivists organized the remaining papers with large letters distinct from the file reference number. These files are in a separate collection, the Secretariat Lettered Papers. In addition, Secretariat Minute Papers that were classified during part of the colonial period, or were given a "C" designation, are found in the C Series collection.

Given the multiple overlapping systems used for cataloging the Secretariat Papers over time, they are presently organized by original reference number within the given box where they were found. Thus, while each box may contain files on a range of topics from various years, the present system maintains the integrity of the original cataloging systems. Only in rare cases where no reference numbers were present, or where the original cataloging structure was indecipherable, was it necessary to add numbers to aid in locating files.
